SUMMARY OF REPORT:

This report recommends revising the fees and charges for 2000 / 2001 following receipt of a ruling from the Australian Taxation Office.

REPORT:

In February 2000 the Trust adopted the fees and charges as submitted by the Executive Manager.

Subsequent to that report advice has been received from the Australian Taxation Office (ATO) concerning the treatment of Holiday Vans. Essentially the ATO ruling requires GST to be levied at 10% for the first 27 days of occupancy, rather than the 5.5% included previously. This has necessitated a recalculation of these fees, which typically has effect in the peak Christmas period when Holiday Van owners are most likely to occupy their vans for more than 27 consecutive days.

In the interests of clarity and to avoid confusion this report also recommends specific fees applicable to all products where occupied for greater than 27 days. Previously only the method of calculation was stated, refer to note a. under heading Price Movement Factors.
