Council is seeking the concurrence of the Tweed Coast Holiday Parks Reserve Trust to the acquisition of an Easement for Sewer Rising Main within the Boyds Bay Caravan Park which is located within Crown Reserve R76814 and Lot 401 in DP 755740. The Reserve is under the trusteeship of the Tweed Coast Holiday Parks Reserve Trust, and the Trust is the registered proprietor of Lot 401. Prior to making an application to the Department of Land & Water Conservation, a resolution from the Trust to approve the Easement is necessary.

The proposed Easement is necessary to enable the abandonment of an existing rising main within Lot 1 DP 865160 held by the NSW Fire Brigade at the corner of Dry Dock Road, Tweed Heads. 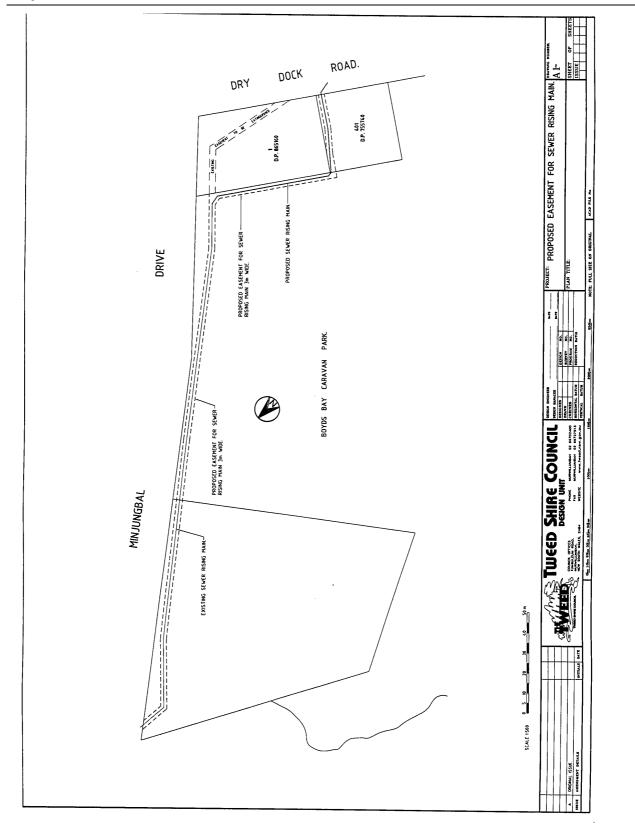
