Dear Dr Griffin

As you are aware, the Hon Tony Kelly MLC, Minister Assisting the Minister for Natural Resources (Lands), has removed Council as trust manager of the Crown reserve over lot 490 DP 47021 at Kingscliff and appointed an interim administrator to manage this reserve. Notices to this effect were published in the Government Gazette of 28 May 2004.

Apart from the many representations he has received, the Minister was critical of the apparent conflict of interest in Council's role as developing the economic base of its local government area, its role as the consent authority and its role as a responsible trust manager.

As far as the Government is concerned, no decisions have been made in respect of lot 490. There has been no decision as to whether lot 490 will be developed, the scope of that development and who will carry out the development.

In the circumstances, the Minister considered that council's recent decision regarding the proposed road through lot 490 was premature given that the development control plan and the plan of management are still in draft form.

The interim administrator, Richard Dunning, will consult extensively, as a matter of priority, with the local community and yourself, to determine the most appropriate development for lot 490. In this regard, the Minister has asked Mr Dunning to establish a steering committee to further the public consultation process. It is intended that Council will be represented on this committee. I expect that Mr Dunning would be in a position to report back to the Minister in three to four months time.


