SUMMARY OF REPORT:

At the Planning Committee Meeting held on 19 October 2005 Council considered a report in respect of the Tweed Retail Strategy which Council's Consultants had prepared. Council resolved that:

"in view of the fact that Council has had the benefit of a substantial amount of data from Consultants over a period of some two years, it is now time for a decision to be made to end the speculation which inevitably surrounds this issue, it is moved that the Planning Committee proposes to recommend adoption of the following strategy at the Council Meeting of 16 November 2005:-

- 1. The character of existing towns and villages and the retail facilities they already have be protected.
- 2. Where appropriate, Council will support the incremental expansion of existing retail centres in such a way as not to threaten or fracture those existing centres, rather than building new ones.
- 3. Reinforce Tweed Heads south as the major district retail centre by encouraging the expansion and when Tweed's population demands that increased range and level of shopping.
- 4. Maintain and wherever possible enhance the special appeal of the retail centre of Murwillumbah and those village centres of similar style.
- 5. Limit the scale of new retail centres in the coastal region to a level which caters for the majority of localised daily needs. This concept to reflect the need to reduce fuel consumption and to support sustainability within each centre.
- 6. Council does not support the establishment of another district retail shopping centre".

The Tweed Retail Strategy report has been deferred from the Planning Committee meeting of 19 October 2005 to allow for public representations to be made on the report prior to adoption by Council. There have been no submissions made in relation to the Tweed Retail Strategy report. In addition there have been workshops with the previous Council and the Administrators with the author of this report. The retail strategy report provides for different retail options in the Shire depending on the growth and desired future character of development in the Tweed.

An additional recommendation "7." has been inserted to address applications received in the interim while statutory documents are being amended.

- 2. Council undertakes a risk management assessment of options for providing life saving services on this long and often dangerous beach at Casuarina.
- 3. Council officers prepare a further report on the acceptance of the tender provided by Surf Life Saving Services Pty Ltd for the provision of beach life saving services at Casuarina Beach over Christmas 2005/06 and Easter 2006 at the tender price of \$28,084.50 (GST exclusive) following the completion of the assessment in (2) above.
- 4. All necessary documentation be executed under the common seal of Council."

Following this resolution, advice was sought and received from Echelon, Risk Management Consultants who are currently engaged in carrying out various risk management tasks for Council. Echelon has advised that they are not qualified to perform the requested risk management assessment in this instance, and it has not been possible to obtain an alternative comprehensive and appropriate assessment within the short time frame available.

In these circumstances, an in-house review of Council's files relating to Surf Life Saving Strategies and Risk Management Insurance has been undertaken which has revealed the historical actions, as detailed in the body of this report, have occurred.

Brief History Relating to Casuarina

- 27.03.2002 Casuarina letter requesting Council's advice on Council's intentions for implementation of monitoring surfing and beach activities (copy attached).
- 26.04.2002 Council reply advising that Council is not involved, and identifying beaches where patrols are provided, and confirming that this Precinct is no different to other unpatrolled, unsupervised areas of beach within Council's area, and that Council does not propose to employ lifeguards for this area (copy attached).

- 2004/2005 Developer advised that no funding available for season. Matter reported to Council Meetings on 17 November 2004 and 1 December 2004 and 15 December 2004, when it was finally resolved:-
 - "... that Council:-
 - 1. Contracts Life Saving NSW for the period 22 December 2004 to 26 January, 7 days per week \$24,171.84 inclusive and for the period 25 March 2005 to 28 March 2005, 7 days per week \$4,565.79 inclusive such expenditure being voted.
 - 2. Accepts the amount of \$10,000 from Consolidated Properties towards the abovementioned costs.
 - 3. Considers this funding in its December budget review."

(copies of reports attached)

2005/2006 Tenders were called for the provision of lifeguard services for all beaches which have traditionally been provided with such services, plus a price for one service at Casuarina Beach. This Casuarina service was not provided for in the 2005/2006 Budget because Council had not formally resolved to provide this service.

The report currently being considered addressed the outcome of the Tenders.

Other Related Documents

A number of other related documents exist on Council files which should be considered in conjunction with the above historical background for Casuarina.

Australian Beach Safety and Management Program

This document identifies Bogangar/Cabarita (South Kingscliff to Bogangar Beach) as having a Beach Safety Rating of 6, which is the same as other beaches in the locality such as the beach to the south, running from Norries Headland south to the mouth of Cudgera Creek, and to the north of Casuarina, the Fingal, Dreamtime, Wommin Kingscliff and Cudgen beaches all are rated at 6.

The document's comment relating to bathing on the beach between South Kingscliff and Bogangar Beach is in part as follows:-

Bathing: A typical open North Coast beach with inner and outer bars and rip currents plus the intervening deep trough and longshore sweep. The currents in the trough and rips are intensified on the falling tide and can generate a dangerous situation.

Strategic Asset and Service Management Program and Policy (SAMP)

Council's Asset Management Plan introduced in 1993 was updated and re-written during 2002 by Council's consultant risk manager to respond to the introduction of new legislation at that time being the Civil Liability Act and the Civil Liability Amendment (Personal Responsibility) Act.

The revised document entitled the Strategic Asset and Service Management Policy (SAMP) was reviewed and adopted by Council on 22 January 2003 and contains important provisions relating to signage for naturally occurring hazards, beach etc supervision and beach patrols.

The Report and Policy is detailed and extensive, occupying some 87 pages and is not reproduced in full, however several of the relevant Sections are re-produced below for Council's information:-

'Section 14.12 (h) Signs

h) No sign or warning shall be erected warning of the existence of any naturally occurring hazard or danger to all humankind—including but not limited to the hazards or dangers attaching to water or the use of water, any watercourse or body of water, wave motion on rocks, foreshores or any structure, freshwater or marine dwelling fish whether or not any such fish is known to be dangerous in any way to humankind, animals, reptiles and insects, or any land dwelling animal, reptile, insect, bird, beaches, cliffs, escarpments, steep slopes, uneven and/or slippery surfaces, trees, shrubs or other flora—within the shire at, along, in, about or around any foreshore, watercourse, or public place, park or reserve.'

'Section 14.29.4 Signage

14.29.4 Signage

14.29.4.1 Generally

a) Subject to 14.29.4.2, signs shall be erected in accordance with **Schedule 6**.

b) Despite Schedule 6, in accordance with the Local Government (General) Regulation 1999 (Part 6, s41), any sign used to "control bathing" (and "bathing" includes surfing and any other similar form of recreation) must comply with Australian Standard AS 2416—2002. This applies to the whole of s.14.29.

14.29.4.2 Placement & Density of Signs

A responsible person shall, after consulting with Council's Risk Manager, determine the location and density (number of signs) to be placed at the respective assets mentioned in **Schedule 6**.

14.30 Public (Ocean) Beach Reserves

14.30.1 Application of Policy

- a) The beaches to which this policy applies are set out in Schedule 1A.
- b) This section does not apply to, and excludes entirely, the Service Agreement between the Council and Surf Life Saving INC.
- c) Subject to 14.30.2, the following management standards shall be adopted unless otherwise provided for in Schedule 4, 4A, or 6.

14.30.2 Determination of Management Standards

A responsible person shall determine the management standards for all public beach reserves respectively.

14.30.3 Supervision of Beaches, Coastline and Other Locations

- a) Except as provided for in Schedules 1A, 4, 4A or 6 respectively:
- b) All beaches within the Tweed shire area shall be unsupervised.
- c) The entire coastline, tidal and/or rock pools, foreshores, estuaries, rivers, lakes, lagoons, dams and the like within or immediately adjacent to Council's defined shire area shall be unsupervised; and
 - No sign will be erected at any beach informing the public:
 - that a beach is unpatrolled;
 - that rescue services are not provided;
 - the location of the nearest patrolled beach;
 - *that bathing or surfing at a particular beach may be hazardous; or*
 - that hazardous bathing or surfing conditions or dangerous sea creatures may exist at any particular beach.

14.30.4 Beaches—Erection of Signs

Subject to s.18.53.5:

- a) All beaches listed in Schedule 1A shall have the following signs erected advising the public:
 - *i.* Where a beach or part of a beach is not patrolled. At each designated entry point erect a sign in accordance with Schedule 6 (Item 2); and
 - *ii.* Where a beach is supervised. In accordance with Clause 2.2 of Australian Standard AS 2416—2002, inform the public:
 - the beach is only patrolled between the flags; and
 - bathing should only be undertaken in the designated patrolled area between the flags.
- b) All beaches other than those listed in Schedule 1A shall have signs erected in accordance with Schedule 6 (Item 2) at each designated entry point provided always that if no designated entry point exists at a beach then no sign shall be erected at the particular beach.
- c) Due to the uncertainty of public telephone placement or services (over which Council has no control), the location of the nearest public telephone (in case of an emergency) shall not be included on any sign.
- d) "Designated entry point (s)" means at each entry point to a beach that has been constructed by the Council, or by a competent public authority, for the purpose of permitting pedestrian or vehicular access to a beach reserve.

14.30.5 Placement & Density of Signs

- a) A responsible person shall, after consulting with Council's Risk Manager, determine the location and density (number of signs) to be placed at the respective assets mentioned in Schedule 6.
- b) A detailed plan shall be prepared and maintained of the location of all signs determined in accordance with a).
- c) An inspection program will be developed for all signs determined in accordance with a).
- d) Despite a), signs shall only erected or placed at a designated entry point(s) and not at any other location on a beach.
- e) Where, at any particular beach, there is no designated entry point:
 - no designated entry point shall be constructed or provided; and
 - no sign shall be erected or placed at a beach where no designated entry point exists.

- f) No sign shall be erected at or about any road, pathway, track or trail leading to any particular beach where the road, pathway, track or trail has been established by public usage.
- g) Signs shall not be erected on or about any road, track or trail specifically constructed for bushfire access by Council, the Rural Fire Service, a public authority, or by any other person.
- A road, track or trail specifically constructed for bushfire access by Council, the Rural Fire Service, a public authority, or by any other person shall not be regarded as a designated entry point.
- *i)* For the purpose of f), "public usage" includes:
 - illegal or unlawful access;
 - access where the public has forced or developed an entry onto a beach whether through scrub or over dune areas or across protected or rehabilitated beach dune areas or parks and gardens, and this includes a road, pathway, track or trail constructed by any person. But "public usage" excludes a road, track or trail constructed by Council or a public authority where the road, track or trail has been constructed for the express purpose of providing a designated entry point to a beach or to any particular part of a beach.

Tweed Surf Life Saving Strategy 2020

This is a draft document which examines current services provided, identifies potential future issues, demands and options which may assist Council in future planning initiatives.

The document was prepared by Geolink in conjunction with Tweed Shire Council staff and representatives from Fingal, Cabarita and Cudgen Surf Clubs and Surf Life Saving NSW.

The document identifies a Surf Life Saving Service located centrally at Casuarina at a future date (see attached Plan marked F).


Other Considerations

Casuarina comprises of about three kilometres of beach with some 22 access points, making the choice and siting of a facility difficult, to ensure that all bathers in all locations at Casuarina are provided for.

Casuarina currently is developed at the northern and southern ends with less development in the central area where the Surf Life Saving facility is provided for in the 2020 Strategy document, again making siting choices difficult.

Casuarina is little different to the many other unpatrolled beaches within the Shire area where public access currently exists and no life saving facility is provided.

Conclusion

Having regard to all of the above, a decision needs to be made as to whether or not the life saving facility will be provided over the forthcoming Christmas and Easter periods.

As previously advised, no funds have been budgeted for this purpose which will cost \$28,084.50.

An additional budget allocation will be required if the service is to be extended to include Casuarina.

If the service is not provided Council could be legally challenged in the event of a mishap.
