COUNCIL'S CHARTER

Tweed Shire Council's charter comprises a set of principles that are to guide Council in the carrying out of its functions, in accordance with Section 8 of the Local Government Act, 1993.

Tweed Shire Council has the following charter:

- to provide directly or on behalf of other levels of government, after due consultation, adequate, equitable and appropriate services and facilities for the community and to ensure that those services and facilities are managed efficiently and effectively;
- to exercise community leadership;
- to exercise its functions in a manner that is consistent with and actively promotes the principles of multiculturalism;
- to promote and to provide and plan for the needs of children;
- to properly manage, develop, protect, restore, enhance and conserve the environment of the area for which it is responsible, in a manner that is consistent with and promotes the principles of ecologically sustainable development;
- to have regard to the long term and cumulative effects of its decisions;
- to bear in mind that it is the custodian and trustee of public assets and to effectively account for and manage the assets for which it is responsible;
- to facilitate the involvement of councillors, members of the public, users of facilities and services and council staff in the development, improvement and co-ordination of local government;
- to raise funds for local purposes by the fair imposition of rates, charges and fees, by income earned from investments and, when appropriate, by borrowings and grants;
- to keep the local community and the State government (and through it, the wider community) informed about its activities;
- to ensure that, in the exercise of its regulatory functions, it acts consistently and without bias, particularly where an activity of the council is affected;
- to be a responsible employer.

Dear Sir,

We understand that a number of houses are to be removed from the bank of the river in River Street, South Murwillumbah, and a public park area will replace them.

The Murwillumbah Historical Society requests, if possible, to have this park named after the Knight Family. Incidentally, one of the houses to be removed was occupied by the Knight family for many years.

The Knight Family is one of the oldest pioneering settlers of the Tweed. Mr. & Mrs. James Knight with their children arrived in the Tweed in 1867 by travelling via the Nightcap Range where the trees were least plentiful. They traveled on a large slide with their belonging hauled by a team of bullocks. During the tortuous journey, Mr. Knight snr. was kicked by a horse and spent a time in the bush recovering with the family mainly looked after by the youthful Thomas (T.D.),who was 13 or 14 years old, and who spent much of his time fishing for food in the neighbouring streams. Eventually the family could move on again and in due course arrived at Tygalgah where they lived for several years and the still youthful Thomas selected land at Dulguigan and married Miss Eliza Kyle of Tygalgah also of pioneer stock.

T.D. Knight also worked making various roads or tracks for a time, carried mail over the Nightcap Range and was a cedar getter with Mr. T.M. Boyd. He was public spirited in the welfare and development of the Tweed representing "A" Riding in the Tweed Shire Council and a director of the Tweed Butchery Co. in 1909 until his death in 1931.

The extending Knight Family also selected land at Crystal Creek, Chillingham and Cudgen Headlands.

There has never been any public recognition of this pioneering Tweed Family and the Historical Society is of the opinion that the naming of a park on the riverbank would be most appropriate to honor this veteran settler of the early days of the Tweed Region.

"Request has been received for the installation of a Convex Mirror on Terranora Road opposite Blue Haze Crescent due to the limited sight distance to the south/west.

The posted speed limit on Terranora Road at this location is 60kph.

Site inspection and photos viewed by the Committee showed that the site distance was adequate for this intersection and that linemarking should be installed on Blue Haze Crescent to show drivers where to stop.

SUMMARY OF REPORT:

Council at its meeting held 24 June 2008 resolved the following:-

- "1. 38 of the 98 ground floor car spaces be restricted to a two hour limit (8.00AM to 5.00PM Monday to Friday), subject to Local Traffic Committee approval;
- 2. The remaining 54 (non disabled) car spaces on the ground floor be restricted to a four hour limit (8.00AM to 5.00PM Monday to Friday), subject to Local Traffic Committee approval;
- 3. The open top level of the car park be allocated as public unrestricted car spaces;



- 4. The remainder of the spaces on the middle level of the complex be paid coupon car parking (Monday to Friday only), subject to Roads and Traffic Authority and Local Traffic Committee approval, for a trial period of six months. The coupons are to be purchased from the Murwillumbah Civic Centre or the Tweed Regional Aquatic Centre (when opened) at the rates stated below:-
 - Daily \$2
 - Monthly \$36
 - Annually \$350;
- 5. The proposal and fees for coupon parking be publicly advertised for a 28 day period prior to implementation;
- 6. Nearby businesses be formally approached to determine their interest in leasing spaces on the middle covered level of the car park complex based on a monthly or yearly rental period at a cost of \$52.00 per month per space or \$550.00 per year per space with increases based on CPI;
- 7. Council staff negotiate with businesses in Proudfoots Lane with a view of relocating reserve parking from behind the shops to the middle level of the car park with a no cost exchange for converting the privately owned parking to 2 hour time restricted parking available to the general public;
- 8. All car parking arrangements adopted for the car parking complex be reviewed six months after the commencement of operation of the car parking complex."

Council resolution items 1 and 2 are forwarded to the Local Traffic Committee for approval.

Council resolution item 4 is forwarded to the Local Traffic Committee for advice.

It is a requirement of the Road & Traffic Authority's "Pay Parking" guidelines that advice be received from the Local Traffic Committee prior to implementation of any pay parking scheme.

The RTA Representative provided the Committee with relevant paid parking guidelines.

The Committee provided advice in relation to Coupon Parking.

SUMMARY OF REPORT:

The Primary School zone can only accommodate 2 buses at a time and in the afternoon six buses pick up students with the third bus reported by the school crossing supervisor as either queuing over the crossing, causing a hazard to children and the crossing supervisor, or the queuing before the crossing holding up traffic on Eucalyptus Drive and through the traffic signals on to Leisure Drive. Council officers have previously met Surfside Buslines representatives on site and advised that buses should queue in the High School bus bay and only enter the Primary School bus bay when it is clear to do so. The Roads & Traffic Authority has written to Surfside Buslines indicating concern with buses obstructing the crossing.

It is proposed to increase the bus zone by approximately 12m to the south towards Covent Gardens Way. This will obstruct access and egress to the teachers' carpark for minimal periods in the afternoon.



An additional road rule came into place 1 July 2008 (NSW Road Rules), being Rule 128A, stating "A driver must not enter a children's crossing, marked foot crossing or pedestrian crossing if the driver cannot drive through the crossing, or a road beyond the crossing, is blocked."

When the Traffic Committee recently installed time limited parking signage on the 90 degree High School side of Eucalyptus Drive the signage was not installed as "Front in Only" which was in place previously. As reversing into these spaces causes traffic congestion it is proposed to designate these spaces as front in only.

The Committee recommended that Council officers discuss the extra bus parking matter with the Primary School Principal and the concerns addressed.

RECOMMENDATION TO COMMITTEE:

That the:-

- 1. Bus zone on Eucalyptus Drive adjacent to Centaur Primary School be extended by one bus space towards Covent Gardens Way.
- 2. On road 90 degree parking spaces on Eucalyptus Drive adjacent to the High School be signed as "Front in Only".

SUMMARY OF REPORT:

Correspondence has been received as follows:-

"Intersection at Laura Street and Pacific Highway, Southbound near Sexton Hill [South Tweed Heads]. At present, traffic flowing onto the Pacific Highway from the egress point of Laura Street, prior to negating the slow Sexton Hill, southbound lane which diverges from here lanes to two are a 'high risk' to traffic from the egress of Minjungbal Drive onto the Pacific Highway travelling southbound. If traffic flow is concentrated upon the southbound lanes one and two [closest to median strip] of the Pacific Highway and you egress from Minjungbal Drive in the third lane [closest to the verge], most of the driving habits I have witnessed of vehicular movement from Laura Street do not look to see if the third lane is clear of oncoming traffic. The driver tends to consider that the traffic flow which negates the third lane is ingressing to Laura Street. My recommendation, could be to consider a 'Stop Sign' at the intersection point of Laura Street and the highway, southbound, prior to Sexton Hill which if risk of a collision occurs, delays become serious, let alone the risk of injury or death."

The correspondent has also provided comment to The Roads & Traffic Authority of NSW on their internet portal site.

'Stop' sign warrants are based on sight distance requirements at mostly an intersection. The Laura Street/Pacific Highway intersection has a sight distance (to the north) of greater than 200 metres with a posted speed limit of 80kph.

Council's crash history for this intersection (2004-2006) shows numerous 'rear end' and 'lose control' accidents at or near this intersection.

Rod Bates queried the length of the merging lane, the RTA Representative to provide this information.
