**SUMMARY OF REPORT:**

Following a presentation to Council by the Tweed Heads Town Centre Revitalisation Task Force, the Jack Evans Boatharbour Reserve Trust at its meeting held on 12 March 2003 resolved:-

*"that the Trust, in principle, supports a review of the 1998 Draft Jack Evans Boatharbour Plan of Management in consultation with the Tweed Heads Town Centre Revitalisation Task Force."*

The Manager of the Task Force has contacted the Trust seeking a nomination from the Trust to participate in a review of the Draft Plan of Management.

**RECOMMENDATION:**

That the Trust nominates Tr Polglase to represent the Trust on the Jack Evans Boat Harbour Reserve Trust Plan of Management Steering Committee.

**REPORT:**

Council on 26 February 2003 received a presentation from the Tweed Heads Central Business District Revitalisation Task Force, which included an outline of the importance of the Jack Evans Boatharbour precinct to the overall redevelopment planning process.

The Jack Evans Boatharbour Reserve Trust at its meeting of 12 March 2003 resolved:-

*"that the Trust, in principle, supports a review of the 1998 Draft Jack Evans Boatharbour Plan of Management in consultation with the Tweed Heads Town Centre Revitalisation Task Force."*

At a meeting with the Task Force Project Manager on Friday, 4 April 2003 it was proposed that a Steering Committee be established to review the 1998 Draft Jack Evans Boatharbour Reserve Trust Plan of Management.

It is recommended that:

1. This Committee comprise representatives from the Tweed Heads Central Business District Revitalisation Task Force, PlanningNSW, Department of Land and Water Conservation, Jack Evans Boatharbour Reserve Trust and officers of Council.
2. The Trust nominates the Chairman of the Jack Evans Boatharbour Reserve Trust as the Trust representative on the Steering Committee.
