

#### Revenue Policy Fees and Charges 2009/2010

#### **Categories of Pricing Policies**

- A Significant Partial Cost Pricing The price for this good/service is set to make a significant contribution towards the cost of providing the service. The remainder of the costs is met from general purpose income.
- **B** Statutory Pricing The price charged for this good/service is a statutory charge set by government regulation.
- **C Minimal Partial Cost Pricing** The price for this service is set to make a minimal contribution to the annual operating and maintenance costs of the facility. The remainder of the costs is met from general purpose income.
- **D** Rate of Return Pricing The price for this service is set to make a contribution towards the cost of replacing the infrastructure assets utilised in the provision of the service.
- **E** Full Cost-Recovery Pricing The price for this good/service is based on the full cost of providing the service.

#### Goods and Services Tax (GST)

- 1 Council applies various fees, charges and fines. The GST status of these will depend on whether there is consideration for a supply. Some fees and charges are exempt from GST in accordance with the Federal Treasurer's Determination under section 81-5 of the A New Tax System (GST) Act 1999. Details of fees and charges subject to GST and exempt from GST are contained in the attached 2009/2010 Fees and Charges.
- 2 A review of the amount of each fee/charge/fine has been undertaken by Council and necessary price adjustments have been made.
- At the time of preparation these Fees and Charges were compiled using the information available from the Australian Taxation Office, Shires Association of NSW and advisors.
