The Tweed Shire Council as corporate trust manager of the listed reserves accepted loans for various improvements, details being;

- <u>Fingal Holiday Park</u> A loan of \$40,000 for BBQ area and seating and a loan of \$50,000 for installation of five ensuite units for the tourist site.
- <u>Boyds Bay Holiday Park</u> A loan of \$200,000 for BBQ facility, games room and children's playground and construction of a retaining wall and a loan of \$340,000 for installation of 12 en-suites, pay television and internet connection and replacement of two non-ensuited cabins.
- <u>Pottsville North Holiday Park</u> A loan of \$285,000 for demolition of the old amenities block and replacement with a new facility and installation of a covered BBQ facility and a loan of \$335,000 for installation of five ensuites, five cabins and pay television and internet connection.
- <u>Pottsville South Holiday Park</u> A loan of \$35,000 for installation of pay television and internet connection.
