a24 [CNR-CM] EC2010-167 Manufacture, Supply and Delivery of DN 300mm Pressure Pipe

SUMMARY OF REPORT:

This late report is a follow up to Item 24 of the agenda and details the tender evaluation for EC2010-167 for the Manufacture, Supply and Delivery of 3500 metres of DN 300 mm Pressure Pipe. Recommendations have been formulated based on the Selection Criteria which is contained in the Tender Evaluation, Pricing Report included in **CONFIDENTIAL ATTACHMENT A**. A summary of the Selection Criteria is also included in the body of this report. It is recommended that Council accepts the tender of Vinidex Pty Limited for the Manufacture, Supply and Delivery of 3500 metres of DN 300mm Pressure Pipe.

REPORT:

Background

Tenders closing 3 November 2010 have been called for the Manufacture, Supply and delivery of DN 300mm diameter Pressure Pipe. The 3500 metres of pipe material will be used for the upgrade of the water trunk main that runs along North Arm Road from Old Lismore Road to the Glencoe Road Reservoir. The pipeline project is due to commence at the end of November 2010.

The tender specified the supply of either of the following pipe materials:

- a) GRP Pipe to AS 3571
- b) Ductile Iron (DI) Pipes to AS/NZS 2280
- c) Steel Pipes to AS 1579
- d) Modified PVC (mPVC) to AS/NZS 4765
- e) Oriented PVC (OPVC) to AS/NZS 4441

The following selection criteria and weightings were used in the evaluation of the tender:

Criteria	Weighting
Tendered Rates	60%
Quality Assurance	10%
Delivery Period	20%
Demonstrated Capability to Perform Service	5%
Relevant Experience with contracts of a similar nature	5%

A total of seven responses were received for tender EC2010-167 Manufacture, Supply and Delivery of DN 300mm Pressure Pipe. Submissions received and pipe materials offered by each supplier are as follows:

Tender Evaluation

The Tender Evaluation was conducted by Council's Tender Evaluation Panel, consisting of Council's Senior Water & Waste Water Design Engineer, Water & Waste Water Capital Works Engineer and Engineering Administration Supervisor. Based on the evaluation contained in the confidential attachment, it is recommended that Tenderer Vinindex Pty Limited be accepted for the Manufacture, Supply and Delivery of 3500 metres of DN 300mm Pressure Pipe.

This tender process is in accordance with Section 55 of the Local Government Act 1993 and Part 7 (Tendering) of the Local Government (General) Regulation 2005.

Funding is provided within the 2010/2011 Budget for the Manufacture, Supply and Delivery of 3500 metres of DN 300mm Pressure Pipe.
