



SUMMARY OF REPORT:

This report proposes fees for new Surfari tents at Hastings Point Holiday Park to apply from 1 July 2010.

RECOMMENDATION:

That the Tweed Coast Holiday Parks Reserve Trust approves the fees for Hastings Point Holiday Park as detailed in the attached worksheet, and that they apply from 1 July 2010.

REPORT:

The attached worksheet details the recommended fees for Hastings Point Holiday Park for the year commencing 1 July 2010. These fees have already been adopted by the Trust at its meeting of 19 January 2010, other than for the new style of Surfari Tent, named the "Bombora".

The Trust is purchasing two (2) Bombora Tents and hopes to have them installed ready for use by September 2010. The Bombora Tents are larger than the existing Surfari Tents, hence the increase in suggested rates.

The Executive Manager recommends the Trust adopt the suggested fee schedule.

3 [EM-TCHP] Laundry Equipment Fees

SUMMARY OF REPORT:

This report proposes new charges for laundry equipment to apply from 1 July 2010 for each of the seven Tweed Coast Holiday Parks.

RECOMMENDATION:

That the Tweed Coast Holiday Parks Reserve Trust agrees to increase all laundry equipment cycle charges from \$3.00 to \$4.00 with effect from 1 July 2010.

REPORT:

The current charge for each washing machine and/or dryer cycle is \$3.00. This has been the fixed charge rate for approximately 6 years.

The reason why this charge has remained in force for this period is twofold. Firstly, to allow market costs to increase sufficiently to justify the 33% increase, and secondly, to avoid the cost and difficulty of converting existing coin mechanisms to accept coins of less than \$1 value.

As the market rate for laundry equipment in caravan parks is now around the \$4.00 per cycle rate it is believed that an increased charge should be introduced to have effect from 1 July 2010.

This report recommends the charge be increased to \$4.00 per cycle for both washing machines and dryers, and that the increase is to have effect from 1 July 2010.
