**SUMMARY OF REPORT:**

This report outlines the tender for EC2011-134 Preliminary Operations Design and Environmental Impact Statement for Tweed River Area 5 Dredging and Sand Delivery Pipeline. Recommendations have been formulated based on the Selection Criteria which is contained in the Tender Evaluation, Pricing Report included in **CONFIDENTIAL ATTACHMENT A**. It is recommended that Council accepts the tender of Kellogg Brown & Root Pty Ltd for EC2011-134 – Preliminary Operations Design and Environmental Impact Statement for Tweed River Area 5 Dredging and Sand Delivery Pipeline.
