#### **Business Arising:**

- 1. The Minutes of the Community Cultural Development Advisory Committee of 21 April 2011 were adopted by Council on 17 May 2011.

### 3. Graeme Stevenson - Creative Industries Art Licensing Project

Graeme provided an update on the project. The television program will go to air in one week and there has been a lot of interest including from Japan. There is the possibility of grant funding through the Public Television Broadcasting Commission. There is the potential for licensing across Australia in the future. In January 2011, a US film crew came to Australia and filmed a program which is being aired in the USA which showcases Graeme and artists based between Byron Bay and Brisbane, and also the local area. The concept could be used in other mediums including music. The Committee watched a segment of the programme.

The Committee thanked Graeme for attending the meeting and providing an update and congratulated Graeme on the project, the concept and his perseverance.

#### G2. Flooding at Art Gallery

The issue of flooding at the Art Gallery during severe weather is being addressed. It is unfortunate that it has happened recently on two occasions. No damage has occurred to artworks to date. Weather shields at the bottom of the doors may require replacement. Approximately 10 windows in the second stage are affected. This work was completed in 2006 and may still be under Builders Warranty.
