### SUMMARY OF REPORT:

**headspace** is a not-for-profit company limited by guarantee, incorporated to promote the improved health and mental health outcomes of young people in Australia. Due to centre expansion, **headspace** is currently seeking Expressions of Interest (EOIs) to undertake the lead agency role for fifteen future locations, including Tweed Valley (Tweed Heads). Medicare Local and On Track Community Programs, which are *'not for profit'* organisations and Artius, a *'for profit'* organisation, have approached Council seeking 'letters of support' for the EOIs submission process for lead agency.

### **RECOMMENDATION:**

That Council provides a 'letter of support' to Medicare Local and On Track Community Programs, and Artius, for their submissions to the headspace project to be located in the Tweed Shire.

# **REPORT**:

**headspace** is a not-for-profit company limited by guarantee, incorporated to promote the improved health and mental health outcomes of young people 12-25 years in Australia. Established in 2006, **headspace** is funded by the Australian Government Department of Health and Aging under the Youth Mental Health Initiative Program.

Due to centre expansion, **headspace** is seeking EOIs to undertake the lead agency role for fifteen future locations, including Tweed Valley (at Tweed Heads). The current request for EOIs is the first stage of a two-stage process for selecting **headspace** centre operators (Lead Agencies) for each location. In the second stage, **headspace** may invite tenders from shortlisted respondents or negotiate a contract directly with those short-listed respondents. **headspace** may also invite tenders from, or negotiate contracts, with others.

Each local **headspace** is managed by a lead agency on behalf of a local partnership (consortium) responsible for the delivery of mental health, drug and alcohol and primary care services as well as community-based providers of vocational assistance and training. Other locally relevant services such as supported accommodation for young people and local government youth services are also important consortia members.

Evidence from existing **headspace** centres has shown benefits to service operation when local government is a participant. Consequently, the guidelines for the EOIs indicate it is preferable to include local government as a consortium member. Each prospective consortium member needs to demonstrate support (in the form of a 'letter of support') including agreement to co-contribute to the initiative. Accepted forms of co-contribution Council could provide include service promotion and community engagement activities.

Medicare Local and On Track Community Programs, which are *'not for profit'* organisations and Artius, which is a *'for profit'* organisation, have approached Council seeking 'letters of support' for their respective EOI submissions.
