## Background

To validly establish an alcohol-free zone a council must comply with the procedures in sections 644 to 644C of the Local Government Act and the Ministerial Guidelines on Alcohol-Free Zones, 2009.

An alcohol-free zone is a means by which a council may limit the locations within its area where the consumption of alcohol is permitted. Matters to be addressed need to include:

#### 1. Reasons to Support the Alcohol-Free Zone

The irresponsible consumption of alcohol on roads and footpaths and in public car parks can compromise their safe use by members of the public without interference. Reasons stipulated must reflect the fact that irresponsible behaviour arising from the consumption of alcohol is occurring on those roads and footpaths and in those public car parks such as obstruction, littering, the actual commission of, or police intervention to avoid the commission of, more serious offences under the *Law Enforcement (Powers and Responsibilities) Act 2002, Summary Offences Act 1988* or the *Crimes Act 1900* such as malicious damage.

#### 2. Location of the Alcohol-Free Zone

An alcohol-free zone may only be established to include a public road, footpath or a public place that is a car park (i.e., car parks on public land or Crown land).

#### 3. Duration of the Alcohol-Free Zone

An alcohol-free zone may be established for a maximum period of four years. Once established, it applies twenty-four hours per day.

Where a problem with irresponsible street drinking exists only in relation to a special event within the local area, an alcohol-free zone may be established only for that special event. An alcohol-free zone declared for a special event also has a maximum duration of four consecutive years.

#### 4. Consultation with the Police

In preparing a proposal to establish an alcohol-free zone a council must consult with relevant police Local Area Commander about the appropriate number and location of alcohol-free zones

## **Application for an Alcohol Free Zone other than is proposed**

# Should you wish to make application to establish an alcohol free zone other than within this proposal:

One or more of the following people may make application to a local council to establish an alcohol-free zone:

- A. a person who is a representative of a community group active in the area,
- B. a police officer, or
- C. a person who lives or works in the area.

An application to Council is to be made in the form set out at the end of this document.

An application fee is not required.

If council receives more than one application referring to the same roads, footpaths or public carparks, they may be joined in a single alcohol-free zone proposal.



Over all or parts of numerous streets and public carparks in the Murwillumbah Town Centre including:

- Queensland Road from 'Harry Williams Gate' of the Murwillumbah Showgrounds to Main Street Murwillumbah, including the car park area near Mount Saint Patricks School on Queensland Road.
- Bent Street from Queensland Road to Church Lane
- Church Lane
- Police Lane
- Queen Street from Main Street to Church Street
- Main Street from the intersection of Nullum Street to Queen Street.
- Wharf Street from Queen Street to Tumbulgum Road.
- Commercial Road from Wharf Street to King Street.
- King Street from Commercial Road to Brisbane Street.
- Brisbane Street from Main Street to Condong Street.
- Condong Street from Brisbane Street to Nullum Street.
- Nullum Street from Condong Street to Main Street.
- Wollumbin Street from Nullum Street to the Commercial Road roundabout.
- Alma Street from the Commercial Road roundabout to the Alma Street/Pacific Highway roundabout.
- Tumbulgum Road from Wharf Street to Racecourse Road.
- Factory Lane.
- Budd Park car park.


