

SUMMARY OF REPORT:

This report recommends the Trust approves the sponsorship request from Salt Surf Life Saving Club in the amount of \$5,900 excluding GST to provide the balance of funds necessary to complete the purchase of a new Thundercat Inflatable Rescue Boat (IRB).

RECOMMENDATION:

That the Tweed Coast Holiday Parks Reserve Trust Approves the sponsorship request from Salt Surf Life Saving Club in the amount of \$5,900.00 excluding GST for the purchase of a Thundercat Inflatable Rescue Boat as detailed in attached invoice #031212.

REPORT:

For Trustee's information the Tweed Coast Holiday Parks has assisted a variety of community service clubs and volunteer groups over the years. The form of assistance provided has been by providing free/discounted site fees for raffles or use in events as well as providing sponsorship to help finance larger projects.

Examples of the latter have been:-

- sponsoring the Cudgen Headland Surf Life Saving Club to assist in the acquisition of a 4 wheel drive all terrain vehicle,
- sponsoring the Kingscliff Volunteer Marine Rescue to help equip its new rescue boat.
- sponsoring a number of Tweed Surf Life Savings Clubs to purchase beach rescue equipment such as rescue tubes, rescue boards, etc.

In recent years the Trust has not provided any significant sponsorship due to the extraordinary costs associated with erosion works limiting available cash flow.

Recently a sponsorship request was received by the Executive Manager of the Trust from Salt Surf Life Saving Club (Salt SLSC) to assist in the acquisition of a new inflatable rescue boat (IRB).

The Executive Manager declares a conflict of interest in this matter as he is a member of Salt, so has passed the matter to the Trust Chairman for consideration and reporting to the Trust should he feel so inclined.

The need for a new IRB is to provide a better response vehicle for rescues and by that enhance the safety of both swimmers and rescue crew. It is also a condition of the lifesaving agreement required by Surf Life Saving NSW (SLSNSW) and all its constituent clubs to have IRBs of the appropriate standard. The new IRB will allow an old craft that has reached the end of its economic life to be retired.

Salt has been successful in obtaining financial assistance from Surf Lifesaving NSW (SLSNSW) in the amount of \$5,500 towards the purchase of the new IRB at a total cost of \$11,400 excluding GST. This assistance was on the basis of prioritised need within the 11 Surf Clubs in the northern branch area; i.e. SLSNSW rated the need for as new IRB at Salt to be a high priority.

Salt SLSC advise that it spends in the order of \$40,000 per annum on the repair, maintenance and replacement of rescue equipment. This expenditure is solely from club funds that it raises by raffles, community drives, and various fundraisers throughout the year.

A copy of the advice from SLSNSW advising of the successful grant of \$5,500 towards the purchase of the IRB is attached, as is a copy of the invoice from Thundercat Inflatables Pty Ltd detailing the purchase cost and specification.
