





#### Revenue Policy Fees and Charges 2015/2016

#### **Categories of Pricing Policies**

- A Significant Partial Cost Pricing The price for this good/service is set to make a significant contribution towards the cost of providing the service. The remainder of the costs is met from general purpose income.
- **B** Statutory Pricing The price charged for this good/service is a statutory charge set by government regulation.
- **C Minimal Partial Cost Pricing** The price for this service is set to make a minimal contribution to the annual operating and maintenance costs of the facility. The remainder of the costs is met from general purpose income.
- **D** Rate of Return Pricing The price for this service is set to make a contribution towards the cost of replacing the infrastructure assets utilised in the provision of the service.
- **E** Full Cost-Recovery Pricing The price for this good/service is based on the full cost of providing the service.
- **F** Reference Pricing The price for this good/service is set by reference to prices charged for similar goods/services provided by like councils.

#### Goods and Services Tax (GST)

- 1 Council applies various fees, charges and fines. The GST status of these will depend on whether there is consideration for a supply.

  Details of fees and charges subject to GST and exempt from GST are contained in the attached 2015/2016 Fees and Charges.
- 2 A review of the amount of each fee/charge/fine has been undertaken by Council and necessary price adjustments have been made.
- At the time of preparation these Fees and Charges were compiled using the information available from the Australian Taxation Office, Shires Association of NSW and advisors. Should the GST legislation or the interpretation of this legislation change, Council reserves the right to increase or decrease the GST component of the Fees and Charges stated and the total fee or charge payable will not change.

#### **Section 94 Contribution Plans**

All Section 94 Contribution Plans applicable to the Tweed Shire are posted on Council's website.

Section 94 Plans contain clauses which allow for annual indexation of infrastructure contribution rates in accordance with the provisions of Regulation 32 of the Environmental Planning and Assessment Regulation 2000. On each 1 July any land purchase component of contribution rates in each Section 94 Plan will be adjusted with reference to the clause in the Plan and the Tweed Shire Council Land Cost index and applied to outstanding development contributions in accordance with consent conditions.

- E Development Application Refund Fee calculated by Town Planner or Building Surveyor as per Section 52 Environmental Planning and Assessment Regulation 2000 will apply when the application is withdrawn in writing by the applicant once lodged in Council's system
