

- Engage with the not-forprofit and business sectors to develop and implement service solutions.

- Provide transparency to enable public scrutiny.
- Observe standards for safety.
- Be fiscally responsible and focus on efficient, effective and prudent use of resources.

# **Outcome** Strategies

### Considering crossborder issues is considered part of business as usual

- Advocate for the inclusion of cross-border issues in government agency strategic and business plans.
- Enhance awareness of cross-border issues within NSW Government agencies through regular and targeted communication.
- Represent the NSW Government in Cross-Border forums.
- Provide advice on complex and / or sensitive issues.
- Provide a conduit for addressing cross-border issues in NSW.
- Develop and implement systems to better identify, analyse and resolve cross-border issues.

#### Enhanced intergovernmental collaboration

- Assist in the development and implementation of cross border MoUs between NSW and neighbouring States and Territories.

- Utilise Joint Organisations and Regional Organisations of Councils to identify, analyse, consider and resolve appropriate local and regional issues and to assist in Local Government collaboration.
- Enhance NSW Government Regional Leadership, Senior Management and Local Government Networks and Groups to consider and resolve appropriate local and regional cross-border issues.
- Develop and coordinate (with other agencies) mechanisms for information flow between jurisdictions to business and communities.

# Government agencies optimise service delivery in cross-border areas

- Provide recommendations to government about resolution of prioritised cross-border issues
- Advocate for innovation in service delivery to more efficiently and effectively support crossborder areas.

#### Changes to the crossborder environment are identified and opportunities realised

Monitor and provide input where appropriate into Commonwealth and State Government reviews and inquiries.
