SUMMARY OF REPORT:

This report provides an update on the action taken since the preparation of the initial report in relation to the proposed Murwillumbah Library Pond upgrade and recommends a way forward following the recent tender and subsequent negotiation process.

REPORT:

Background

Tender RFP2015-129 Murwillumbah Library Pond Upgrade was called to engage a suitably qualified and experienced organisation to provide construction services to redevelop the pond area adjacent to the Murwillumbah Library and the main stairs to Tweed Shire Council office. As per the previous Council Report, no tenders were recommended for acceptance due to budget constraints and negotiations commenced with the lowest price tenderer in accordance with Local Government Regulation 2005 Clause 178.

Negotiation Details

An initial site meeting was held on 24 November 2015. Council staff indicated to D'Bah Enterprises Pty Ltd that the project cannot move forward in its current design form due to budget constraints and seeks to negotiate a scope of works that could be within Councils budget. A series of potential savings from minor design changes were identified and discussed at the meeting. Council staff subsequently prepared a revised design and scope of works for repricing on 30 November 2015.

D'Bah Enterprises Pty Ltd provided an offer on 2 December 2015 after careful consideration of the new scope of work and design drawings. The offer is within Councils budget. The design intent and Architectural elements remain the same so it is considered that this is a reasonable outcome from the negotiation process.

Direct negotiations have been undertaken in accordance with Independent Commission Against Corruption (ICAC) guidelines as required by the Local Government Regulation 2005.

Recommendation

As per Local Government Regulation 2005 Clause 178, it is recommended that Council endorses the actions of the negotiation process conducted by Council staff.

It is recommended that the tender from D'Bah Enterprises be accepted to the value of \$171,387.27 excluding GST.

Therefore, that, in respect of Contract RFP2015-129 Murwillumbah Library Pond Upgrade:

- 1. Council enters a contract with D'Bah Enterprises (ABN 61 850 361 870) for the amount of \$171,387.27 (exclusive of GST).
- 2. The General Manager be granted delegated authority to approve appropriately deemed variations to the contract and those variations be reported to Council at mid contract and finalisation of the contract.
