### SUMMARY OF REPORT:

A Youth Conference is being conducted at Twin Towns Services Club on Saturday 10 October 2015 and unfortunately the venue is double booked.

The Club have approached Council requesting if suitable marquees can be erected on Jack Evans Boat Harbour Parkland to enable this conference of approximately 700 people to proceed.

The current practice is to not allow conferences of this type to be conducted on Council reserves, but in this instance it is seen as being of a benefit to the community to allow this conference to take place within the Parklands. The facilities of the Twin Towns Services Club will be utilised by the participants and this report is seeking the concurrence of the Reserve Trust in erecting the appropriate marquees and holding the conference. It is noted that the marquees will be dismantled immediately following the conference.

It should be noted that this is a one-off situation and is not to set a precedent for future events of this type.
