# **Background**

Following a report by officers regarding the future water supply for the Shire, Council resolved on 19 November 2015:

"that this matter be deferred for consideration at 18 February 2016 Council meeting and arrangements made for a series of independently facilitated Workshops to be held with the interested stakeholder groups."

# **Workshops Content**

It is proposed an information pack containing information associated with the augmentation of the water supply and options that would increase the longevity of the existing or any future water supply be sent out to those attending the workshops at least 7 days before the first workshop.

The information to be presented in the initial workshop will include the following:

- 1. An overview and purpose of the workshops, namely to inform and seek feedback.
- 2. A review of demand:
  - a. demand as predicted by MWH
  - b. demand management implemented
  - c. impact of demand management measures
  - d. impact of BASIX (and hardening of demand)
  - e. current forecast demand based on ID Consulting and Hydrosphere
- 3. Determination of secure yield of Clarrie Hall Dam:
  - a. how secure yield is calculated
  - b. present secure yield
  - c. secure yield impacted by climate change
- 4. Intersection of present demand projections and secure yield:
  - a. history of secure yields
  - b. the present position
- 5. Categories of Options:
  - a. augment supply
  - b. increase longevity of supply
  - c. both
- 6. Options for augmented supply:
  - a. Raise CHD cost, longevity, section 64 and Typical Residential Bill (TRB)
  - b. Byrrill Ck options cost, longevity, s64 and TRB
  - c. SEQ Water Options cost, longevity, s64 and TRB

- 7. Options for extending longevity:
  - a. what has been done to date
  - b. demand hardening
  - c. rainwater costs (capital and \$/kL), ability to extend longevity of existing supply
  - d. rebate programs costs (capital and \$/kL), ability to extend longevity of existing supply
  - e. dual reticulation and reuse of effluent costs (capital and \$/kL), ability to extend longevity of existing supply
  - f. others

It should be noted that some of the information Council holds on these items is now approximately 6 years old and would require updating for the purposes of the workshops. This is due to price increases and hardening of demand as a result of the implemented demand management measures.

The analysis on the basis of capital cost and \$/kL will allow comparison with options for augmented supply on a like basis.

A period for questions will be provided for the purposes of clarifying the information provided.

The second workshop will be to provide further information by way of clarifications sought and to solicit, from each of the representatives from interested stakeholder groups, their group's preferred strategy to guarantee a secure water supply after 2026.
