# **SUMMARY OF REPORT:**

Request for Offer RFO2016077 was called to ensure continued electricity supply to Council's small infrastructure after contract EC2013-217 which expires on 31 December 2016.

The offer was advertised as per the requirements of the Local Government Regulation 2005 and closed at 4:00pm NSW Local Time on 7 December 2016.

At the time of closing 5 Offers were received.

The evaluation of the offers against the Selection Criteria is contained in the Offer Evaluation Report included in **CONFIDENTIAL ATTACHMENTS 1 and 2.** The recommendations are based on the evaluation.

## **RECOMMENDATION:**

- Council awards the contract RFO2016077 Electricity for Small Sites from 01

#### **REPORT:**

## Offer Background

This Request for Offer has been prepared for the purpose of engaging a suitably qualified and experienced provider to supply Retail Electricity for Council operated sites within Tweed Shire for a 3 year contract period commencing 1 January 2017.

The sites are those deemed as small sites by their consumption profiles and site meters. Council operates approximately 370 Small Sites consisting of Office Buildings, Sewer Pump Stations, Water Pump Stations, Commercial buildings and Recreational Facilities. Around 95% of Council's small sites operate under the Business tariff BLNN1AU.

# **Request for Offer Advertising**

The Offer was invited in accordance with the provisions of the Local Government Act 1993, the NSW Local Government (General) Regulation 2005 and the Tendering Guidelines for NSW Local Government. The Offer was officially advertised on Tuesday 5 July 2016 in The Sydney Morning Herald and also on 2 July 2016 in both the Brisbane Courier Mail and the Gold Coast Bulletin. It was also advertised in the Tweed Link on 4 July 2016.

# **Offer Addendums**

There were 3 addendums (Notice to Bidders) issued before close of Offer.

Addendum No.01 advised Bidders that the closing date had changed from 26 October to 19 October. The notice also provided bidders with a list of sites and their historical consumption figures to enable competitive pricing.

Addendum No.02 advised Bidders that the closing date had changed from 19 October to 30 November. This change of closing was required due the amended council elections and planned first meeting of the new Council being 8 December.

Addendum No.03 advised Bidders that the closing date had changed from 30 October to 7 December. This change of closing was required due the amended council meeting dates and planned second meeting of the new Council being 15 December 2016.

#### Offer Submissions

Offer submissions closed at 4.00pm (local time) on 7 December 2016 in the Tender Box located in the foyer at the Tweed Shire Council Civic and Cultural Centre, Murwillumbah NSW 2484. At the closing time for Offer submissions, the Tender Box was opened and 5 Offers were recorded as below:

### **Evaluation Results**

Details of the price and non-price evaluation are shown on the Offer Evaluation Report and Offer Evaluation Scoring Sheet. A copy of the Offer Evaluation Report and Offer Evaluation Scoring Sheet are included as ATTACHMENTS 1 and 2 which are CONFIDENTIAL in accordance with Section 10A:

The information identifies the Bidder in relation to the Offer price and the evaluation of the products offered by the Bidder. If disclosed, the information would be likely to prejudice the commercial position of the Bidder in terms of market competitiveness by giving their competitors an advantage. Accordingly, disclosure of the information is not in the public interest. Recommendations appear below for the Offer.

Energy Australia achieved the highest overall assessment score and is therefore deemed as the most advantageous option for Council.

Based on Council's May 2016 Small Site Power site list and consumptions, the total estimated cost over 36 months (3 years) for a supply contract with Energy Australia would be \$3,147,042.92 (incl GST).

Local Content scoring was not applied as no other offer fell within the cost cap calculations.

#### Recommendations

It is recommended that the Offer from Energy Australia ABN 99 086 014 968 be accepted as per the schedule of rates offered and that Council approves delegation to the General Manager to sign a Retail Electricity Supply Agreement with Energy Australia before the offer expires at close of Business on 16 December 2016.

# **OPTIONS:**

That Council:

- Awards the contract RFO2016077 Electricity for Small Sites from 01 January 2017 to Energy Australia ABN 99 086 014 968 in accordance with the Retail Electricity Supply Agreement (3 Year Contract) and the Schedule of Rates offered.
- 2. Awards the Contract to a different Bidder, including reasons for this course of action.
- 3. Declines to accept any of the Offers, including reasons for this course of action.

#### **CONCLUSION:**

It is recommended that the Offer from Energy Australia ABN 99 086 014 968 be accepted as per the schedule of rates offered and that Council approves delegation to the General Manager to sign a Retail Electricity Supply Agreement with Energy Australia before the offer expires at close of Business on 16 December 2016.

Based on Council's May 2016 Small Site Power site list and consumptions, the total estimated cost over 36 months (3 years) for a supply contract with Energy Australia would be \$3,147,042.92 incl GST.
