Request for Offer RFO2016093 Supply of Three (2) Wide Area Mowers, was called to supply Council operations with the following:

Three (3) replacement Wide Area Mowers for existing aged unit's as per Council's 10 year asset replacement strategy.

The three wide area mowers are to be used for ground maintenance by Council's Recreation Services Unit's Tweed Heads and Tweed Coast sites.

Offers were officially invited in accordance with the provisions of the Local Government Act 1993 and the NSW Local Government (General) Regulation 2005. Offer submissions closed at 4.00pm (local time) on 20 July 2016 in the Tender Box located in the foyer at the Tweed Shire Council Civic and Cultural Centre, Murwillumbah, NSW, 2484.

Recommendations have been formulated based on the Selection Criteria which is contained in the Offer Evaluation Plan Report included in **CONFIDENTIAL ATTACHMENTS 1 and 2.** A summary of the Selection criteria is also included in the body of this report.
