SUMMARY OF REPORT:

Offer RFO2016017 was called to engage a supplier to supply Council with stormwater products for the Elanora Avenue Southern Catchment Drainage Project.

As per the Local Government (General) Regulation 2005 Clause 178 Acceptance of Tenders, offers were considered and it was assessed that no offer provides value to Council. It was recommended that Council declines to accept any of the tenders.

It was recommended that Council enter into negotiations with any person (whether or not the person was a bidder) with a view to entering into a contract in relation to the subject matter of the Request for Offer. It was recommended that negotiations commence with companies that are known to supply concrete pipes to Australian Standards namely Rocla Australia Pty Ltd and Humes Pty Ltd.

Recommendations have been formulated based on the Selection Criteria which is contained in the Offer Evaluation Plan Report included in **CONFIDENTIAL ATTACHMENT 1**.
