


LAYOUT PLAN - JOHN FOLLENT PARK

REVETMENT NOTES

- THE CONTRACTOR SHALL CONFIRM THE SUITABILITY OF THE DESIGN ONSITE AND INFORM THE SUPERINTENDENT OF ANY POTENTIAL ISSUES PRIOR TO STARTING THE WORKS.
- THE SETOUT LINE FOR THE WORKS SHALL BE DETERMINED ONSITE CONSIDERING THE LOCATION AND ELEVATION OF BANK AND EXISTING REVETMENT MATERIAL.
- ALL ROCK ONSITE SHALL BE SORTED AND ASSESSED FOR REUSE IN THE PROPOSED STRUCTURE.
