

## Proposed changes to permitted off leash areas in parks and reserves.

### Existing off leash areas – no changes

Corowa Park	Corner of Chinderah Rd and Terrace St, Chinderah.	0.5 ha	There two off leash areas in Chinderah located within 100m. Turnock St Park also includes a neighbourhood playground.	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for off leash areas.
Boyd Family Park	Off Piggabeen Rd, Tweed Heads West	2.6 ha	No change	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for permitted off leash areas.
Frangela Drive Reserve	Frangela Drive, Murwillumbah	4.26 ha	No change	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for permitted off leash areas.
River St Park	Between No. 73 and 89 River St, Murwillumbah	0.4 ha	No change	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for permitted off leash areas.
Lillie Park	End of Old Ferry Rd, Oxley Cove	0.7 ha	No change	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for permitted off leash areas.
Bilambil Road Reserve	Corner of Naponyah Rd and Bilambil Rd, Terranora	0.7 ha	No change	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for permitted off leash areas.
Bilambil Road Reserve	Corner of Naponyah Rd and Bilambil Rd, Terranora	1.0 ha	No change	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for permitted off leash areas.
Bushland Drive Oyster Point Rd Park	Bottom of Bushland Drive, Banora Point	0.2 ha	No change	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for permitted off leash areas.
Ducat Park	Ducat St, Tweed Heads	2.2 ha	No change	Retain as an off leash area and upgrade to a neighbourhood level in accordance with the hierarchy for permitted off leash areas.

Amaroo Park	Darlington Dve, Banora Point		The draft Open Space Strategy recommends that Amaroo Park be repurposed to a district level park and playground to service the broader Banora Point community's recreation needs.	The permitted off leash area be relocated to Banora Green (located within 700m of Amaroo Park).

### New off leash area relocated from a nearby park

Park/Beach Location	Description	Length/Area	Rationale	Key changes/recommendation
Banora Green	Darlington Dve, Banora Point.	To be determined	Relocate the off leash area from Amaroo Park to Banora Green.	Develop as a regional off leash area in accordance with the hierarchy (include fencing and agility equipment). Other considerations include off street parking and fencing to protect sensitive natural area. Consult with local community to identify whether the entire park area or a section of the park be off leash.

### Rationalisation of one off leash area

Park/Beach Location	Description	Length/Area	Rationale	Key changes/recommendation
Turnock St Park	Turnock St, Chinderah	1.1 ha	Located adjacent to a children's playground and located within 100m of a second off leash area in Chinderah.	Remove Turnock Park as an off leash area and retain the off leash area in Corowa Park.

Sweetnam Park	Kyogle Rd, Uki	0.3 ha	Located adjacent to a children's playground and an arterial road. May need to consider fencing the off leash area if appropriate buffer distances cannot be obtained.	Provide a new neighbourhood level off leash area in accordance with the hierarchy.
Suter Park or A section of Arkinstall Park (south of the playground),	Dry Dock Rd, Tweed Head South  Cunningham St, Tweed Heads South.	0.7 ha  0.7 ha	May need to consider fencing the off leash areas if appropriate buffer distances cannot be obtained from roads or the children's playground in Arkinstall Park.	Council to consult with local residents and sporting clubs to identify the preferred location for a neighbourhood off leash area.
Bray Park Reserve	Corner of Kyogle Rd and Tree St Murwillumbah	0.3 ha	A central location for a district level off leash area for residents of Murwillumbah and surrounds.	Provide a new district level off leash area in accordance with the hierarchy (include fencing, no agility equipment initially). Agility equipment will be trialled in Banora Green, Banora Point.

Old Fingal Boat Harbour Park	Fingal Rd, Fingal Head.	0.4 ha	Located adjacent to a children's playground and a collector road. May need to consider fencing the off leash area if appropriate buffer distances cannot be obtained.	Council to consult with local residents to identify the preferred location for an off leash area.
