INSPECTION REPORT

STORZ HOSE CONNECTIONS / HOSE COUPLINGS

Pursuant to the provisions of Section 119T(1)(b) of the Environmental Planning and Assessment Act 1979 (EP&A Act) and Clause 189(a) of the Environmental Planning and Assessment Regulation 2000 (EP&A Regulation), Authorised Fire Officers from the Fire Safety Compliance Unit of Fire and Rescue NSW (FRNSW) inspected of a number of buildings in the Tweed Shire Council area between Monday 5 February 2018 and Thursday 8 February 2018.

The inspection was conducted in response to concerns surrounding the lack of Storz Hose Connections in the Tweed Shire Council area. Including the possible increase in population numbers to Hotels / Motels (Class 3 accommodation) during the Commonwealth Games.

On behalf of the Commissioner of FRNSW, the following comments are provided for your information in accordance with Section 119T(4) and Section 121ZD(1) of the EP&A Act. Please be advised that Section 121ZD(2) requires any report and recommendations from the Commissioner of FRNSW to be tabled at a Council meeting.

COMMENTS

As discussed with the Acting Team Leader Building Certification Services for Tweed Shire Council on 7 February 2018, the following premises have been identified and observed without Storz Hose Connections during the inspections:

As a result, it was difficult to determine the building standard that applied at the time of construction, particularly as a number of buildings failed to display an Annual Fire Safety Statement in accordance with Clause 177 of the Environmental Planning and Assessment Regulation (EPAR).

Please be advised that additional reports shall be provided at a later date identifying specific concerns in relation to each property as listed.


