# **Aboriginal Cultural Heritage Management Plan 2018 adopted**

Council adopted the Aboriginal Cultural Heritage Management Plan 2018 (ACHMP) at its meeting on 5 July 2018.

The ACHMP and mapping represents a significant body of work, in consultation with the Aboriginal community over a fouryear period

It comprises a thematic history, shire-wide mapping and the management plan document and is a significant step forward for the protection of Aboriginal cultural heritage in the Tweed.

There are two layers to the Aboriginal cultural heritage mapping: Aboriginal Place of Heritage Significance (Known) and Predictive Aboriginal cultural heritage.

The ACHMP has been developed to assist property owners understand their statutory requirements and to understand their risk of harm and will be triggered when undertaking development which requires development consent.

The plan seeks to provide clear practices and processes to assist the understanding of the sensitivity and occurrence of Aboriginal cultural heritage (ACH). It provides pathways for ensuring that individuals have the right tools and information at their disposal to meet their obligations under the law and to enable cultural heritage to be properly assessed and managed.

It is important to note that the actions to prevent 'harm' to Aboriginal cultural heritage are not new. Legislation for the protection of Aboriginal cultural heritage has been in place since the introduction of the NPW Act. This Act makes it a prosecutable offence should harm be caused to Aboriginal cultural heritage.

The Plan builds on current legislative framework of the National Parks and Wildlife Act, 1974 (NPW Act) and the draft standalone Aboriginal Cultural Heritage legislation and Bill recently exhibited by the Office of Environment and Heritage (OEH).

## **Smooth handover for Tweed's tourism promotion**

The successful tenderer for promotion of Tweed's tourism for at least the next four years met with the outgoing body early last week, in a meeting facilitated by Council.

The purpose of the meeting was to discuss the transition from Destination Tweed to DR Tourism and addressed issues such as staffing, volunteers and visitor information centres.

Council's General Manager, Troy Green said it was an amicable meeting, with goodwill evident from both parties.

"While no agreements were reached at this initial meeting as both entities needed to refer options to their respective boards, Council was pleased with the professional attitude of the both parties," Mr Green said.

"There was an 'in principle' agreement to work together to produce a smooth and positive transition in the best interests of the tourism industry and the community."

DR Tourism Director, Robbie Cornelius agreed that the meeting



was positive and said DR Tourism was looking forward to working with Destination Tweed through the transition process and beyond.

"We absolutely recognise the great work that has been achieved by Destination Tweed and our broad approach is going to be one that builds on the momentum and success achieved by the organisation rather than starting from scratch," Mr. Cornelius said.

"It was clear in the meeting that both DR Tourism and Destination Tweed have the best interests of the local industry and its tourism operators at heart, and as such both entities are keen to work together closely in the lead up to October to ensure a positive changeover for all," he said

Destination Tweed Chair, Kylie Ryan-Milroy said Destination Tweed looked forward to completing a seamless handover to DR Tourism by the due date.

"As a representative industry body since 1990, Destination Tweed has almost 30 years of local history and relationships and we're excited to redefine our role via our members to determine how best to continue to support and grow this unique destination and its players."

At the 19 July council Meeting, DR Tourism won the contract to promote tourism in the Tweed from 1 October 2018. The contract is for four years, with another four-year option.

The current operator, Destination Tweed, will continue to run tourism services until 30 September 2018.

## Many benefits to relining

Council contractors are continuing work to reline over 7 km of gravity sewer mains with a glass-reinforced plastic liner at Tweed Heads, Kingscliff and Murwillumbah.

The no-dig technology allows Council to renew pipes for another 50 years of serviceable life for a fraction of the cost it would take to replace them. Every year, Council spends about \$1.5 million renewing small sections of pipe at risk of failing within our 550-kilometre gravity sewer main network.

The technology uses a soft sock lining which is pulled through the main using a D-shackle, rope and winch. The sock is then filled with air so it hugs the internal wall of the pipe, before being exposed to ultraviolet light to cure in-situ.

Whether the original sewer pipe is concrete installed in the '50s, vitrious clay installed in the '60s or asbestos cement installed in the '70s, and regardless of its dimensions, the glass-reinforced plastic lining provides a perfect refurbishment.

The benefits of relining the worst section of our pipes pay dividends not only in keeping the raw sewerage in but in keeping the rain and groundwater out.

Every millimetre of water that enters our sewer has to be processed along the entire sewerage processing chain. The less water that gets in, the less our operating costs, wear and tear on pumps and electricity needed to run them.

It will take about a number of months to complete our current relining project. Later in the year, we will call tenders to reline a further eight kilometres of our gravity sewer network.

Meanwhile, contractors are also out and about assessing the condition of a further 20km of our sewer network using a pipe camera to identify any fractures, cracks, invasion by tree roots or illegal connections to set next year's relining program.

### **Museum to open Sundays**

The Tweed Heads branch of the Tweed Regional Museum will open to the public every Sunday between 10am to 4pm from Sunday 5 August.

Tweed Regional Museum Director Judy Kean said the Museum was delighted to now be able to welcome visitors to the Museum every Sunday rather than just once a month.

"The opportunity to fully enjoy this valuable community space every weekend has been realised just as the extensive refurbishment of the Museum's heritage buildings is nearing completion," Ms Kean said.

The ongoing refurbishment of the Tweed Heads Museum heritage precinct commenced in 2015 with each stage opened upon completion. The original Tweed Heads Court House reopened with a range of new displays in October 2017. In April 2018, the new access pathway allowing visitors to better appreciate this important heritage building was also completed.

"The next stage of work is focusing on Boyd's Shed," she said.

"The fishing prowess of the Tweed's Boyd brothers, together with role that the shed played is well remembered by locals and well documented in the Museum collection.

"This wonderful building, long used by the Boyd family, has a rich history and is full of stories which will once again be the focus of new displays when the Shed reopens later this year."

The Shed was built in 1907 and was used as the storage and 'staging post' for the brothers' fishing activities until their last catch in 1969. It continued as something of a social hub into the 1970s before falling into disrepair. The shed was relocated to its current site within the Museum precinct from further along Terranora inlet in the mid-1990s and restored thanks to the efforts of many locals and the Tweed Heads Historical Society.

The Shed has been well cared for over the years, but the nature of the building, its location, and the elements have had an impact. Some running repairs will be necessary before the building reopens to the public," she said.

The Tweed Heads Museum Precinct is located at Pioneer Park, Kennedy Drive Tweed Heads. The new opening hours from 5 August coincide with celebrations for Local Government week 2018.
