## Ben's riding blind at 266km an hour

**Council is proud to welcome Ben Felten as the guest speaker at the 2018 Tweed Shire Access and Inclusion Awards, which will be held on Friday 3 December – the International Day of People with a Disability.**

Born fully sighted, Ben Felten developed a degenerative eye disease which left him completely blind by his late 20s – but that has never held him back from a life full of achievements.

In March 2018 Ben won the world speed title for blind motorcycle riding at the South Australia salt plain Lake Gairdner. He was assisted in his record winning attempt by former MotoGP racer Kevin Magee.

Council's Community Development Officer – Ageing & Disability Karen Collins said Ben's passion for inclusion set him apart from other advocates of providing opportunities for people with disability.

"Ben encourages everyone, with or without a disability to pursue his or her dreams and turn them to reality," Ms Collins said.

"If you know a person, business, community group organisation in our community who you think should be recognised for their work towards making the community a place where everyone can join in, please nominate them for the 2018 Tweed Shire Access and Inclusion Awards."

#### Slow down or risk fines

**A new road rule requiring motorists to slow down to 40kmh while passing a stationary emergency services vehicle displaying flashing blue or red lights came into force in NSW last weekend.**

The rule will be trialled for 12 months to measure its effectiveness of keeping everyone safe during a roadside incident. Motorists who fail to comply with the rule will face a \$448 fine and three demerit points.

## Living with magpies

**The magpie is a loved Australian bird and as a ground feeder of insects and pests, it has an important role in natural pest management for farms and gardens.**

During magpie breeding season this Spring please remember the male birds only swoop to protect their young.

Please remain aware and take the following precautions:

- avoid swooping areas and, where possible, take a different route away from nesting trees (magpies live in their territories for many years and do remember humans)
- wear a hat or carry an umbrella and protect your eyes
- attach a flag to your bike and dismount if swooped
- leave the area quickly without running

It is illegal to harm or kill magpies. If menacing swooping occurs on Council managed land such as park or road reserve contact Council on (02) 6670 2400.

If swooping occurs on private property or public bushland contact the National Parks and Wildlife Service.

# ReCycling unused bikes

Tweed Coast bike shops are offering to service old bikes in reasonable working order so they can be 'reCycled' and distributed to those in need of two good wheels during Bike Week at the end of the month.

The initiative is being driven through Transport NSW's Bike Week, supported by Council, The Family Centre at Tweed Heads, Kingscliff Cycle Centre, Border Bikes and Coast Cyclery.

"We are asking the community to donate their unused and outgrown bikes that might be clogging up the shed to be fixed up and then given to those in need," Council's Road Safety Officer Alana Brooks said.

"Bike Week is about encouraging riding for short trips and recreation and promoting bike safety.

"Our ReCycle initiative will enable people, to get around their neighbourhood under their own pedal power at no financial cost and in a way that improves their health and well-being.

"The new bike owners will also be provided with a helmet, bike repair kit, pump, Tweed Cycleways map and safety gear," she said.

Residents are asked to drop their unused adult or children's bikes during September to one of the participating bike shops during business hours so they can be serviced and ready to be re-gifted.

The bike shops are generously donating their time to service the bikes.

The bikes will then be donated to The Family Centre at Tweed Heads for distribution to clients in need of two wheels during Bike Week from 22–30 September.

# Have your say Tweed's new open space strategy

Community consultation is about to begin on Council's draft Open Space Strategy 2018–2028, which sets Tweed Shire's open space vision and provides the framework and strategic direction for public open space planning in the Tweed for the next 10 years.

Council's Manager Recreation Services, Stewart Brawley said public open spaces are the places we go to picnic with our family and friends, play sport, visit a playground, socialise, walk, cycle, sit at lunchtime, encounter nature and engage in cultural activities.

"Open spaces accommodate a range of sport, recreation and park facilities that provide a wealth of recreational, environmental and tourism opportunities for the Shire," Mr Brawley said

"Given the importance of open spaces and sport and recreation to the Tweed Shire community and the significant pressures anticipated by residential growth and visitor use, it is a priority that a strategic and integrated approach to open space planning be undertaken."

The Open Space Strategy is the product of extensive consultation with residents, stakeholders, open space users and the broader community.

Supporting this strategy, but presented as a separate document, is a series of Local Action Plans, containing local strategies and actions to improve the Tweed's open space network.

The Local Action Plans will be placed on public exhibition on Tuesday 11 October 2018. Council will then host a series of Community Conversations during October and November in 15 locations across the Shire. The aim of the Community Conversations is to work in collaboration with local communities to prioritise local

strategies and actions to ensure community needs are met.

The outcomes of the Community Conversations will inform the development of a detailed Implementation Plan, which will be included in the final Open Space Strategy.

**Cudgen** – sub-division works may cause delays on Crescent Street between Tweed Coast Road and Cudgen Road. There are two separate subdivisions with road works and trucks accessing the sites (reduced speed limits in place).

**Dulguigan** – guardrail footing construction Dulguigan Road.

**Hastings Point** – construct bus stop lane on Tweed Coast Road.

**Kielvale** – road reconstruction Reserve Creek Road, 5km east of Wulffs Lane.

**Kingscliff** – Cudgen Creek boardwalk reconstruction.

**Murwillumbah** – stormwater replacement Condong Street; replace kerb and gutter William Street.

**Numinbah** – temporary traffic lights installed at culvert construction Pat Smith Creek.

**Terranora** – possible short delays on Henry Lawson Drive due to subdivision works (Coach Road to Tennis Courts).

**Tumbulgum** – road repair McAuleys Road.

**Tweed Heads** – sewer rising main upgrade Meridian Way; road reconstruction Enid Street.

**Tweed Heads South** – kerb and gutter upgrade Kirkwood Road, between Fraser Drive and Philip Parade.

**Uki** – guardrail installation for Black Spot Program Kyogle Road, between Glenock Road and Gold Gully; and resealing, patching various locations Kyogle Road.

**Maintenance South** – resheeting Manns Road, Doon Doon; Limpinwood Valley area; Nunderi.

**Maintenance North** – revetment Mooball Creek, Pottsville; maintenance Terranora area; Tweed Coast Road.
