Food forum to harvest ingredients of success

The burgeoning food industry in the Tweed and the wider region will be the focus of the inaugural two-day Food for Thought Forum, to be held at Kingscliff on 11 and 12 August.

Presented by Tweed Shire Council, the forum will bring together a range of players along the food chain, ranging from paddock to plate and everything in between.

Council's Director Corporate Services, Liz Collyer, is a passionate 'foodie' who developed the forum with Council's Sustainable Agriculture Officer, Eli Szandala.

"We want to start a conversation about food here in the Tweed and recognise and celebrate the wonderful opportunity we have to boost our economy through food tourism," Ms Collyer said.

"We have productive and innovative farmers and producers across the Tweed, a thriving farmers' market scene, a range of food-oriented events and some wonderful cafés and restaurant showcasing local produce.

"This forum presents an opportunity to bring all those sectors together so we can work more collaboratively to make the Tweed known as the place to go to experience fresh local food.

"There's so much opportunity here in the Tweed and we've seen so many other regions do it very well.

"Our neighbours to the north-west, Scenic Rim Regional Council, provide a wonderful example of how food tourism can bolster a local economy and bring thousands of tourists to a region," Ms Collyer said.

This year's Eat Local Week attracted 23,000 people who attending 84 events across the Scenic Rim. These events included farm tours, cooking classes, dining experiences and book launches.

The Mayor of Scenic Rim Regional Council will be sharing the 'Eat Local week' success story as a speaker on day one of the forum.

A heavily polluted green waste collection last week has highlighted the fact some Tweed residents are still unsure about what they should place in each of their bins.

A SOLO kerbside organics truck returned to the Stotts Creek Resource Recovery Centre with a very high proportion of non-organic waste, taking staff a considerable time to remove the non-compatible materials.

Acting Coordinator Waste Management Mark Longbottom said organics waste collected from residents' green bins is processed to produce mulch, so the material can be reused.

"Polluting this material with non-organic waste reduces the quality of mulch we produce," he said.

"Only organic materials such as sticks, leaves grass clippings and other garden prunings can be placed in the green bins.

"It's also important other non-compatible

material is kept out of the organics collection so the processed mulch can be reused in the community without harmful environmental impacts.

He said community education about the bin service is ongoing and most residents do the right thing.

'But there are still some people who are unclear about the role of each bin," Mr Longbottom said.

"Materials put in the wrong bin often have to be manually removed during sorting and processing and significantly increases processing costs, and that added expense is ultimately borne by the whole community.

Mr Longbottom said the correct use of bins would become even more important when Council introduces a new organics waste service which would enable residents to put all food and garden waste in their green bin.

Burringbar green link restored

Forty hectares of vegetation linking Burringbar Range to the coast has been restored in a three-year threatened species recovery program winding up this month.

Landholders and Council have been working together since August 2013 to restore the habitat of threatened species and Endangered Ecological Communities, involving eight private properties and 600 plants.

Landholders, working in partnership with bush regenerators, received tuition in plant identification and weed control techniques, enabling them to better differentiate between native plants and weeds.

The targeted area is recognised in the Border Ranges Rainforest Biodiversity Management Plan as a Priority Implementation Area for conservation and protection, It contains 12 threatened plant species and supports a large number of threatened animal species.

"By controlling weeds and promoting native regeneration in forest gaps and edges, habitat connectivity is improved and this strengthens the viability of populations of threatened plants and animals," Council's Project Officer -Biodiversity, Michael Corke, said.

Two workshops attracting 54 people showcased control techniques for some of the Shire's most invasive weeds and outlined landholder obligations for noxious weed control.

"These community events encourage landholders to get involved in conserving native habitat. They provide opportunities to spread the message that simple actions on private land, such as regular and effective weed control, can play a vital role in threatened species conservation."
