Tweed Heads PCYC Facility Development Project (DA 04/0533, CC05/0698)

As you may be aware the Tweed Heads PCYC is undertaking a significant redevelopment of its building to provide improved facilities and services for young people and the wider community, which is anticipated to be completed by August

The project, consisting of an extension and facility improvements, will encompass an auditorium capable of holding youth dance parties and other events which can also be divided into 2 multi-purpose rooms, a games room, canteen/café area, educational room equipped with computers, band rehearsal space, new offices and toilets, and a new roof on the existing building. An office and access to other facilities will be made available for other youth and community agencies to utilise in the upgraded Club.

Improvements to the existing building include replacing the roof and guttering, replacing & upgrading exit doors, electrical work, painting and refurbishment of the sports floor

The current range of services of the club include:

- A range of sport and recreational activities basketball, boxing, break dancing, monthly dance parties, gymnastics, kindy gym, judo, ju-jitsu, concert band/music, weights gym and limited school holiday activities.
- Crime prevention and youth development services alternative schooling program (Partnerships in Learning), personal development program for at risk young people (Break Away), young women's personal development program (Girlfriend), truancy patrols, case management of young offenders, school lecturing programs and Traffic Offenders Program.
- Fundraising initiatives markets, trivia night, raffles, barbecues, golf day, donations.
- A community pre-school also operates from the PCYC facility 5 days a week

Although predominantly focusing on services for young people, PCYC membership is open to all ages. In 2005 the club had over 700 registered members, ranging from 2 years old to 80.

Over 16,000 attendances were recorded for last year and it is anticipated that membership and attendances will increase significantly with the opening of the new facilities

The new facilities will allow a greater diversity of services including.

- Enhanced youth entertainment options dance parties, band nights, movie nights, drop-in activities (pool, electronic games, listening to music, watching tv and videos)
- Rock band rehearsal space feeding in to band nights
- Education and training programs continuation of PIL, Traffic Education
 Program, homework support and other opportunities including support of such
 programs as Links to Learning, Youth Pathways, JPET and vocational
 training programs
- Enhanced school holiday activities for youth and children (possibly funded vacation care)
- · Other sport and recreation activities drama, indoor soccer, floorball
- · Art and craft activities
- Increased fitness activities (for young people to seniors) aerobics and boxercise
- Greater opportunities to participate and cater for Youth Week activities and other special events
- · Access to other youth services and workers

Although planning for the project commenced some three years ago, the range of improved facilities and services to be provided is consistent with local youth needs based on the recent youth needs analysis commissioned by Council (of which I participated on the steering committee) and the Tweed Coolangatta Community Safety Action Plan.

Cost of the project is in excess of \$1.7 million and is being funded through PCYC State Office/NSW Police Service (\$1 million), Cwith Dept Transport & Regional Services (\$291,875), Tweed Heads Bowls Club (\$82,810), Tweed Shire Council (\$50,000), NSW Sport & Recreation (\$27,500) and the Tweed Heads PCYC (balance of around \$250,000 generated from local fundraising activities)

The commitment and contribution from PCYC to the project is significant (\$1.25 million) particularly when once considers that the building is on crown land managed by Council and leased by PCYC (current lease expiring in December 2010 with a further 10 year option)

Council's contribution of \$50,000 from the Drug Prevention Strategy is greatly appreciated, however the ongoing requests by Council for fees relating to the project is of much concern

To date we have paid all fees with the exception of the DA development contributions which is being paid in annual instalments

Recently we received an additional request from Council's Trade Waste Officer, Gary Cain to pay \$4,131 to increase the water supply to the building to a 50mm connection (tax invoice not provided). I forwarded a fax to Gary Cain and Peter Holmes on that day seeking advice on how that fee is calculated and I'm still awaiting a reply.

This latest fee (which one could argue should be accommodated with the Water Headworks fee) will take the total of Council imposed fees to \$41,093. In over 12 years experience working with PCYC in NSW including 11 years in State Office I have not encountered such significant fees being imposed by a council for a PCYC facility project, including completely new buildings.

PCYCs in both NSW and Queensland generally receive significant support from councils with building projects through donations/grants, waiving/reduction of DA/CC related fees and in-kind works.

Some recent examples include:

All three Gold Coast PCYC projects supported by Gold Coast Council over the past 2 years:

- Ashmore PCYC \$930,000 in funding from GCCC, \$26,000 in DA related fees waived, CC and other fees limited to approx \$5,000, in-kind works to the value of \$20,000.
- Gold Coast PCYC, Broadbeach Waters \$265,000 in funding from GCCC, over \$20,000 in DA/CC related fees waived
- Nerang PCYC \$115,000 in funding, fees totalling \$3,000 waived. In 1997 GCCC also provided \$300,000 to the club for major works

Across NSW PCYCs have been supported by Councils in recent years across the State including

- Waiving/reduction of DA and CC related fees Broken Hill, Coffs Harbour (fees of approx \$15,000 of which \$14,000 was waived/reimbursed), Gosford, Kempsey, Lithgow, Liverpool, Port Stephens and Young (nil fees to PCYC).
- Significant financial contribution to building projects Bourke (new club, Council providing facility & cost of upgrading), Gosford (over \$500,000), Liverpool (over \$2 million), Marrickville (provided new facility), Tamworth & Young (over \$1 million).
- Operating subsidies and grants Armidale, Bathurst, Fairfield, Lake Macquarie, Marrickville, Moree, Mudgee, North Sydney, Parramatta, Port Stephens, Randwick, Shellharbour, Sutherland & Tamworth

Recommendations

I seek approval for Council to waive the water connection fee for \$4,141 and ask that Council reconsiders waiving or significantly reducing the development contribution fees of which \$30,622.67 remains to be paid

Any further fees imposed by Council will reduce our budget available for equipping the facility to the determinant of the proposed facilities and services, and our users

PCYC is a non-profit company working in partnership with the NSW Police providing a range of services to divert young people from crime and to provide developmental opportunities for young people and the wider community through sport, recreation and education

I am also forwarding a number of letters of support for our project from a range of local agencies and stakeholders. I look forward to Council's reply, Please let me know if you require any additional information.
