Council officers have noted an increase in articulated vehicles (40 – 50 GVM) straddling the kerb and footpath on Tumbulgum Road between Sunnyside Lane and Old Ferry Road Murwillumbah.

It appears that due to the traffic lane widths, semi-trailers cannot negotiate this section of road without either crossing into the oncoming traffic lane or staying in the traffic lane, and allowing the trailer wheels to track onto the pedestrian path.

The current speed limit is 40km/h on this section of road.

It is suggested that the section of Tumbulgum Road between Sunnyside Lane and Old Ferry Road Murwillumbah be restricted to use by vehicles under 14.5 GVM. The changes will still allow for the use of buses on this section of road.

Attached are two (2) maps indicating the road section and the proposed wording and sign type approximately 50 metres prior to the intersection.

This section of road is proposed to be upgraded in the next financial year where lane widths will be widened and the road camber improved. It is proposed that prohibitive signage restricting the weight of vehicles be installed temporarily until these works are carried out.

SUMMARY OF REPORT:

Request received in relation to the corner of Kyogle Road near 1248 Kyogle Road, Dum Dum.

It has been reported that there have been four vehicle accidents which have left the road at the corner of 1248 Kyogle Road and crashed through fencing on to this property. The most recent accident was on Anzac Day 2016 where the vehicle crashed through the fence and hit the power pole adjacent, resulting in loss of power to neighbouring properties.

It is suggested that the super elevation of the corner could be a factor in accidents.

Council is in the process of surveying this section of Kyogle Road with the intention of informing future remedial works and will provide information for any future Black Spot application. The Roads & Maritime Services (RMS) is currently conducting a speed review on Kyogle Road and this section will be included in that review.

That given the very low through traffic using this access lane off Powell Street and likelihood of non compliance with any "No Entry" signage the designation of this as a one-way lane is not supported.

Surfside Buslines have advised that this is an ongoing issue for bus drivers and there have been several prangs on this curve.
