

Historic bridge restoration underway

Work has begun to restore Dunbible Bridge, one of 5 bridges to be restored as part of the construction of 24km Tweed section of the **Northern Rivers Rail Trail.**

Much of the rail and bridge infrastructure along the trail is significantly damaged and decayed, making it unsafe and unsuitable for public use. These restoration works will see some bridges receive a much-needed facelift including removing the old lead paint and repainting.

American-inspired steel through-truss bridges became a hallmark of the North Coast Railway Line, which first opened in 1894.

Tweed Regional Museum Director Molly Green said the Dunbible Creek Railway Bridge was a good example of a steel through-truss bridge.

"This is a fascinating restoration process and it is great the project team is prioritising documentation of the changes to contribute to the ongoing story of our rail history," Ms Green said.

Since construction of the trail began in late 2021, contractors have completed an archival record of 11 bridges across the length of the Tweed section of the trail to ensure these records will be shared with Tweed Regional Museum to add to their collection.

Other preliminary works also underway include the completion of a Geotechnical and Foundation Study, clearing works and the installation of a trial surface which has required rails to be removed.

Project Director, Iain Lonsdale said the rail infrastructure was in a state of disrepair.

"While its condition is unsuitable for its intended purpose, it is important to us that we reuse, recycle and to minimise waste," Mr Lonsdale said.

"It is likely that the majority of rails removed during construction works will be repurposed as pylons within the foundations for new building construction overseas."

"We are retaining a small length of reclaimed rail to potentially incorporate into infrastructure such as seating, sign/fence posts, or tables along the rail trail and have earmarked metal sleepers, plates, clips and bolts to be recycled at the Newcastle Steel Mill.'

As contractors continue construction and restoration works along the trail, there may be traffic delays in the following locations in the next few weeks:

- Dunbible Stokers Road
- Stokers Siding Stokers Road, The Bloodwoods Road and **Tunnel Road**
- Mooball Tweed Valley Way
- Crabbes Creek Tweed Valley Way

Cabarita Beach viewing platform temporary closure



The viewing platform at Cabarita Beach in front of the surf club is temporarily closed after routine maintenance works found the timber substructure to be in poor condition.

An assessment is being undertaken on the extent of works required to make the structure safe again, and associated costs.

Council is working to resolve the matter as soon as it is practical. Alternative accessible locations to take in the ocean view are at Faulks Park, Rowan Robinson Park and Murphys Road at Kingscliff and the boardwalk at Ambrose Brown Park in Pottsville.

Frogbit: Have you seen this invasive waterweed?



Frogbit (Limnobium laevigatum), is a fast-growing, floating aquatic weed that poses significant threat to our already struggling local waterways. Forming dense mats, Frogbit threatens native aquatic animals by reducing available food and shelter and inhibiting light to native water plants. It can block waterways and irrigation channels and limit recreational water activities.

There are currently three known locations in our region of this invasive water weed – at Chinderah, Dorroughby and a recent sighting at Swan Bay which are being actively managed, but we need your help to find more! This weed is listed as **high risk** and is a state and regional target for **prevention**. It is therefore classified as prohibited matter.



Frogbit can be identified by its bright green, round fleshy leaves, up to 4cm across. Young leaves float flat on the water surface and have a spongy underside, and as they mature grow above the water surface and lose their sponginess. Flowers are small and white.

The fruit is a berry-like capsule that develops underwater, containing up to 100 floating seeds which are easily dispersed by water or wind once released and can remain viable for at least 3 years. Frogbit can also spread vegetatively, when fragments attach to animals or water equipment and are transported to new areas.

Similar looking plants include the native Frogbit (Hydrocharis dubia) – which also occurs in our region – but has larger leaves (up to 6cm long) and flowers are 2–3 cm across with 3 round white petals and yellow centres.



Please do not attempt to treat or dispose of Frogbit yourself. If you see this plant, report it immediately to Rous County Council on 02 6623 3800. We will lead an initial response for the treatment and disposal of the plant to stop it from spreading.
