COUNCIL'S CHARTER

Tweed Shire Council's charter comprises a set of principles that are to guide Council in the carrying out of its functions, in accordance with Section 8 of the Local Government Act, 1993.

Tweed Shire Council has the following charter:

- to provide directly or on behalf of other levels of government, after due consultation, adequate, equitable and appropriate services and facilities for the community and to ensure that those services and facilities are managed efficiently and effectively;
- to exercise community leadership;
- to exercise its functions in a manner that is consistent with and actively promotes the principles of multiculturalism;
- to promote and to provide and plan for the needs of children;
- to properly manage, develop, protect, restore, enhance and conserve the environment of the area for which it is responsible, in a manner that is consistent with and promotes the principles of ecologically sustainable development;
- to have regard to the long term and cumulative effects of its decisions;
- to bear in mind that it is the custodian and trustee of public assets and to effectively account for and manage the assets for which it is responsible;
- to facilitate the involvement of councillors, members of the public, users of facilities and services and council staff in the development, improvement and co-ordination of local government;
- to raise funds for local purposes by the fair imposition of rates, charges and fees, by income earned from investments and, when appropriate, by borrowings and grants;
- to keep the local community and the State government (and through it, the wider community) informed about its activities;
- to ensure that, in the exercise of its regulatory functions, it acts consistently and without bias, particularly where an activity of the council is affected;
- to be a responsible employer.

SUMMARY OF REPORT:

Tenders were officially invited for Kennedy Drive Asphalt Works in the Sydney Morning Herald on Tuesday 27 March 2012. Tender Submissions closed at 4:00pm (local time) on 18 April 2012 in the Tender Box located in the foyer at the Tweed Shire Council Civic and Cultural Centre, Murwillumbah NSW 2484. Two (2) responses were recorded at the Tender Box opening being:

- Boral Asphalt
- Tropic Asphalt

This report recommends a preferred tenderer to undertake the works.

RECOMMENDATION:

That in relation to tender EC2012-122 Kennedy Drive Asphalt Works:

1. **The tender from Boral Asphalt be accepted to the value of \$333,448.29 exclusive of GST.**
2. **The General Manager be given delegated authority to approve variations up to \$150,000 above the initial tender price and those variations reported to Council following completion of works.**

The tender was also advertised in the Brisbane Courier Mail on 24 March 2012 and the Tweed Link on 26 March 2012. Tender Submissions closed at 4:00pm (local time) on 18 April 2012 in the Tender Box located in the foyer at the Tweed Shire Council Civic and Cultural Centre, Murwillumbah NSW 2484. Two responses were recorded at the Tender Box opening.
